Eric Reid Fund for Methodology – Application Form questions

The grant provides modest support for benchwork of up to £6,670. This can be split between a student and consumables, with London Living Wage increases available. We particularly encourage applications from newly appointed PIs, early career researchers seeking independence, and researchers returning from a career break.

Examples of awards include:

- Method development by new staff before they apply to a major award-granting body.
- Developing a new technique.
- Checking the application of a known technique in new circumstances.

Please note: This grant is aimed at basic science, specifically the development of analytical/biochemical methods. This fund is not intended for clinical therapeutics.

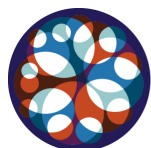

This is based on a 35-hour week at National Living Wage, or the project is taking place in London, then the London Living Wage is applied for a maximum stipend of £3,108. Shorter projects are also welcomed.

- The sum of money requested and how it is to be spent.
